Cell Phones in Schools

Overview

This survey is for students aged 13-18. We will ask about your use of digital devices (e.g., smartphones, laptops, tablets, headphones) at school, your school's policies around these devices, and how all the above impact your experiences as a Student.

About the Survey

This survey should take no more than 10-15 minutes to finish.

- All information we collect will be completely anonymous.
- There are no known risks associated with participating in this study.
- For completing this survey, you will be compensated according to the agreement in place with the survey company you've signed up with.
- Participants will only be compensated for completing this survey once.
- There are "attention check" questions throughout this survey to avoid bot responses and invalid responses. Responses that fail these checks will not be compensated and will be reported to your survey company. Failed responses may also be logged on your profile.
- The survey is completely voluntary and you are free to skip survey questions you don't want to answer. Please keep in mind that there are no right or wrong answers. What counts is your opinion.
- All responses will be kept confidential. Data that combines everyone's answers will be reported. Direct quotes from open-ended responses may be reported; however, no identifiable information will be included.
- You are free to withdraw from the survey any time up until the "Submit" button is pressed at the end of the survey. Because this is an anonymous survey, once results are submitted it is not possible to withdraw.

School Policies
